COMING FROM THE WEST I-94

Take the St. Cloud exit and proceed through St. Joseph. Continue traveling east once you arrive in St. Cloud. You will be on Division Street (Highway 23). Stay on Division Street. You will take a left on Washington Memorial Drive. Go one block. At the "T", turn right onto St. Germain Street. Follow St. Germain Street into the downtown area. Turn left onto Seventh Avenue North. We are located in the second building on the left. Metered parking can be found to the north and east. We are located on the third floor in the Daniel Building.

COMING IN ON HIGHWAY 10 FROM I-94

FROM THE CITIES:

Take the exit for Hwy 10 off of 94 when you get to Clearwater. Go through town, cross railroad tracks, and at stop light take a left to St. Cloud. When you get to the outskirts of St. Cloud, there will be an overpass you will drive under. At the first set of lights, which is right after the overpass, you'll take a left onto East St. Germain, next to Copper Lantern. Follow St. Germain Street over the Mississippi River. At the third set of stop lights (approximately four blocks - Seventh Avenue North) turn left. We are one block up, first building on the right. We are located on the third floor of the Daniel Building in between Taste of Seattle and Quizno's. Metered parking can be found to the north and east. There is a parking ramp a block and a half north also.

COMING IN ON HIGHWAY 10 FROM LITTLE FALLS:

Following the two Sauk Rapids exits as you get to the outskirts of St. Cloud, there is a set of stoplights. Take a right at those stoplights onto East St. Germain. Follow St. Germain Street over the Mississippi River. At the third set of stop lights (approximately four blocks - Seventh Avenue) turn left. We are one block up, first building on the right. We are located on the third floor of the Daniel Building.

COMING IN ON I-94 FROM THE CITIES (1-94):

Take the first St. Cloud exit. It is the St. Cloud/St. Augusta exit. Take a RIGHT at the bottom of the ramp. You will then be on County Road 75. At the fifth set of stop lights (Washington Memorial Drive) turn RIGHT. Continue on Washington Memorial Drive until you cross Division Street. You will come to a "T" intersection. At the "T", turn RIGHT onto St. Germain Street and proceed toward the downtown area. After the 3rd set of lights, go one block to Seventh Avenue North. Take a LEFT at the four-way stop. We are the second building on the left (Daniel Building right next to Taste of Seattle coffee shop). Metered parking can be found to the north and east. There is a parking ramp a block and a half north also.

FROM WILLMAR AREA (WEST 23)

Take Highway 23 into St. Cloud. Continue traveling east once you arrive in St. Cloud. You will be on Division Street (Highway 23). Stay on Division Street. You will take a left on Washington Memorial Drive. Go one block. At the "T", turn right onto St. Germain Street. Follow St. Germain Street into the downtown area until you reach Seventh Avenue North. Turn left. We are located in the second building on the left. Metered parking can be found to the north and east.
